### REGULAR PROGRAM FEE:

\*\$75 non-refundable registration fee per family. Registration fee AND 1<sup>ST</sup>. SESSION FEE is due along with the application form. Tuition fee of \$300 per 4-week period for first child. \$280 per 4-week period for any additional sibling. Session 10 will be a 2-week period and the rate will be prorated to \$150 per child and \$130 per any additional sibling. **FACULTY/SCHOOL EMPLOYEE FEE:** School staff/employee \$75 registration fee per family and \$150 tuition fee per child for all sessions. Payments can be made online at [www.afterschool-connections.org/payment](http://www.afterschool-connections.org/payment). **PAYMENT POLICY & PROCEDURES:** Payments must be made prior to the start of the attendance period. **There is stringent no refund/no credit policy.** Including but not limited to, unexpected school closures, inclement weather/hurricanes, pandemics, child sickness, withdrawn/dismissed from the program or school. If your payment is late, we will charge a \$25 late fee. These fees are based on an annual tuition of services provided and are divided into equal payment periods for your convenience. The above schedule of fees will apply for children of all age levels. As stated in our Student Parent Handbook under Payment Policy, **effective May 1<sup>st</sup> through end of school year, we will no longer accept payments in the form of an ACH.** This includes but is not limited to tuition, late payments and late pick-up fees. We will only accept online payments. Please visit our website at [www.afterschool-connections.org/payment](http://www.afterschool-connections.org/payment) to make an online payment. \*Credits do not roll over from previous school years or summer program. All payments made must be used for the registered session of the program. **RETURNED ACH CHARGE:** If you choose to make the payments by ACH and if there is a returned notification, a charge of \$25 will be made and all subsequent payments must be made online via credit card for a period of one year. **ACH will be charged on the 1<sup>st</sup> day (Monday) of the payment week for each session.** **LATE PICK-UP CHARGE:** The late pick-up fee is **\$1.00 per minute, per child** after 6:00 p.m. This fee is due by credit card upon picking up your child. After 3 late pick-ups in the same 4-week session, we reserve the right to drop your child from our enrollment.
