**REGULAR PROGRAM FEE:** \$50 non-refundable registration fee per family. Registration fee is due along with the application form. Tuition fee of \$210 per 4-week period for first child. \$189 per 4-week period for any additional sibling. Session 10 will be a 3-weeks period and the rate will be prorated to \$160 per child and \$145 per any additional sibling.

**FACULTY/SCHOOL EMPLOYEE FEE:** School staff/employee \$50 registration fee per family and \$60 tuition fee per child for all sessions. **PAYMENT POLICY & PROCEDURES:** Payments must be made prior to the start of the attendance period. **There is stringent no refund/no credit policy.** Including but not limited to, unexpected school closures, inclement weather/hurricanes, pandemics, child sickness, withdrawn/dismissed from the program and or school. If your payment is late, we will charge a \$25 late fee. These fees are based on an annual tuition of services provided and are divided into equal payment periods for your convenience. The above schedule of fees will apply for children of all age levels. As stated on our Student Parent Handbook under Payment Policy, **effective May 1<sup>st</sup> through end of school year, we will no longer accept payments in the form of a CHECK.** This includes but is not limited to tuition, late payments and late pick up fees. We will only accept money order, cashier check or online payments. Please visit our website at [www.afterschool-connections.org](http://www.afterschool-connections.org) to make an online payment.

**RETURNED CHECK CHARGE:** If you choose to make the payments by check and if there is a returned check, a charge of \$25 will be made and all subsequent payments must be a money order or credit card for a period of one year.

**LATE PICK-UP CHARGE:** The late pick up fee is **\$1.00 per minute, per child** after 6:00 p.m. This fee is due by check or credit card upon picking up your child. After 3 late pick-ups in the same 4 week session, we reserve the right to drop your child from our enrollment.
